**Having read the kart track in all its areas open to the public and the regulations in force below, expressly declares and acknowledges the following:**

1. to be in good physical shape and therefore not to be under the influence of alcoholic beverages, drugs or medicines and not to have physical impediments or illnesses that would affect one's ability to drive;
2. to have attended the briefing during which the track manager specified the characteristics of the kart, the route and the driving behavior to adopt;
3. to undertake to respect the **Driving regulations** of the kart track, attached to this declaration, which the undersigned has read and to follow the instructions given by the kart track staff.

### **KART TRACK REGULATIONS (Read carefully)**

Please follow the rules, which are necessary to ensure the healthy and safe enjoyment for everyone, including you. To drive the Go-Karts, it is mandatory to fill in and sign the release of liability.

- Kartroma LLC is expressly exonerated from any liability for damages that the user may cause while using the kart. It will not be held responsible for any injury or damage that the applicant may suffer due to his/her negligent or involuntary conduct. The user is exclusively responsible for all damages caused by the use of the kart inside the facilities. In the end, the applicant relieves kartroma LLC of any liability from which he/she declares that he/she has nothing to claim in relation to the careless performance of the aforementioned sporting activity.
- It is strictly forbidden to touch other go-karts while driving or voluntarily drive into the safety barriers. Any crash or collision between go-karts, going off-track or races between vehicles, incorrect or dangerous driving behaviors are prohibited. The infringer may be immediately removed by the track director without having anything to claim; on the contrary, the rights of Kartroma LLC to compensation for any damage caused to the karts, the structures of the facilities and/or third parties by the applicant remain unprejudiced and

unaffected.

- The applicant is required to pay compensation for damage caused to the karts or structures due to the conduct referred to above.
- It is strictly forbidden to drive under the influence of drugs or alcohol.
- It is mandatory to facilitate overtaking of the person behind if they are evidently faster.
- It is mandatory to wear a well-fastened full face helmet.
- If the kart stops in the middle of the track, it is strictly forbidden to get out of the kart: raise your right arm to signal and wait for the track attendant. In the case of karts stopped on the track, this means that it was stopped on the track for safety reasons. Also, in this case, it is absolutely forbidden to get out of the kart.
- It is strictly forbidden to hit the kart in front and it is forbidden to get out of your kart until the last kart on the track has stopped at the pits.
- Karts are expensive vehicles, built with high professionalism and used by many people before and after you. **For this reason, it is mandatory to resort to one's common sense, one's civility and respect for others. For this, we are grateful to you.**
- Place the helmet where you picked it up. Discard the balaclava in the appropriate containers.
- It is strictly forbidden to wear scarves, bulky jackets and wide trousers, shoes with excessive heels or beach shoes. Loose hair that exceeds shoulder length must be tied.  
Wearing clothing or objects that could compromise the normal course of karting activity
- It is strictly forbidden to get off and leave the kart on the track during the racing sessions and to walk to the pits.
- **I hereby certify that I am the parent, and that the child is already ten (10) years old.**
- It is forbidden to introduce balls/footballs, and to leave any animals (dogs, cats) roaming free within the premises.
